## STABLEMAN AGREEMENT

This agreement made on \_\_\_\_\_, by and between Kilshannagh Veterinary Clinic PC, hereinafter referred to as "Stableman", and

---

hereinafter referred to as "Horse Owner".

WHEREAS Horse Owner is desirous of maintaining one horse:

---

on said property for a period of time on a monthly basis and/or daily basis, and

WHEREAS Stableman and Horse Owner are desirous of setting forth their respective rights and liabilities with regards to said arrangement,

NOW, THEREFORE, in consideration of the foregoing and mutual covenants and conditions passing from each to the other, the parties do agree as follows:

- 1) Horse Owner may board his horse on Stableman's property for an open-ended period of time.
- 2) Stableman will provide boarding (custody, care and control) of Horse Owner's horse on the following basis –

Full Board includes daily feeding, watering, mucking, blanketing if requested, and turn out. Partial Board requires Horse Owner to be responsible for feeding, watering, mucking, blanketing and turning

out on a twice daily basis. Full Turnout Board includes permanent turnout in a paddock with a run-in shed, daily feeding, watering and blanketing as requested. Partial Turnout Board requires Horse Owner to be responsible for feeding, watering and blanketing.

Board is due and payable in advance by the first day of each calendar month. There will be a \$50 late fee for payments received after the 15<sup>th</sup> of the month. Stableman reserves the right to impose a surcharge on items not covered by the basic board and will notify Horse Owner(s) of such two (2) weeks in advance of billing the additional charges.

- 3) Horse Owner shall supply all veterinary and other medical care, including transportation and related cost, and insurance for surgery or loss of use that may be necessary in Horse Owner's sole discretion for the maintenance of said horse.
- 4) Horse Owner agrees to vaccinate horse on a six-monthly basis for influenza and rhinopneumonitis, on an annual basis for rabies, maintain a current Coggins and worm every six weeks.
- 5) HORSE WILL BE WORMED ON ADMISSION TO OUR FACILITY AS A MATTER OF POLICY.
- 6) Horse will be wormed on the same schedule as all the other horses at the farm. Worming is an additional charge.
- 7) It is expressly understood and agreed that all other responsibilities associated with the maintenance of said horse, including but not limited to any damage to Stableman's property or third parties caused by said horse, shall be solely the responsibility of Horse Owner.
- 8) Each rider of Owner's horse must sign the farm release form. Exercise may be arranged if needed through the farm.
- 9) Horse Owner shall have the right to enter upon Stableman's property during reasonable hours to groom, ride and otherwise maintain said animal.
- 10) This contract shall be construed under the laws of the State of New York.
- 11) Any changes, additions or deletions must be in writing signed by both parties.
- 12) This constitutes the entire agreement between the parties including the liability waiver attached which is incorporated and made part of this agreement. There are no separate oral understandings not expressly set forth herein.
